- _____ I understand that if during said inspection it is found that I have made false statements on this adoption agreement or I have not adequately provided for the animal's wellbeing, the result may be the nullification of this adoption and surrender of the animal to the authorized SACARC representative.

TERMS OF ADOPTION

- 1. Care of Our Rescues:** Our rescues are adopted to loving homes who want an animal for the love and companionship they offer. As rescues, our dogs and cats have already been through enough heartache in their lives. Animals adopted from *Springfield Animal Care and Rescue Club (SACARC)* will not be used for animal research or experiments, breeding, attack training, or dog fighting; they will not be tied up or chained, confined exclusively outdoors, abused, neglected, given to another owner (see Transfer of Ownership), or abandoned to the streets. SACARC reserves the right to check on the status of our rescued animal and to request updates, removing our rescued dog or cat if we discover these terms are violated by the adopter; there will be no refund of the adoption donation.
- 2. Return:** The adopted animal may be returned to SACARC within two weeks of the date of adoption for full refund of payment if the adopter is not satisfied with any aspect of the adoption. We will accept return of the animal at any point in his/her life; however, after two weeks from the adoption date no refund will be given.
- 3. Transfer of Ownership:** The adopted animal may not be transferred to any other person for any reason without prior approval of SACARC. If the undersigned adopter is forced to relinquish custody of the animal at any time, said dog or cat will be relinquished only to *Springfield Animal Care and Rescue Club* or a reputable no-kill shelter if the adopter has moved out of Florida or other designee if approved by unanimous vote of the board of *Springfield Animal Care and Rescue Club*.
- 4. Refund:** There will be no refund or reimbursement for any expenses incurred by the adopter for the adopted animal, even if it is returned to SACARC.
- 5. Health Program:** The adopted animal will be cared for humanely, including adequate food, shelter, water, heartworm preventative, flea medication, vaccinations, and any other necessary veterinary care and will be licensed in accordance with the laws in the jurisdiction in which he or she resides. Any adopted dog is to be exercised in a fenced yard (including off-leash dog parks) or on a leash and shall NOT BE FREE TO ROAM THE STREETS.
- 6. Loss:** If the adopted dog or cat is lost or stolen, the adopter will notify SACARC immediately so we can use our resources to help locate the animal as soon as possible.
- 7. Reservation of Rights:** SACARC reserves the right to enforce this contract in order to protect the welfare of the adopted animal. It is understood that SACARC may examine and may make inquiry about said animal at any time after adoption and will do so. We appreciate updates and photos of our adopted dogs and cats. If the terms and conditions of the Adoption Contract are not upheld, SACARC reserves the right to terminate the Contract and to reclaim the dog or cat; there will be no refund of the adoption donation.
- 8. Liability:** If the animal develops behavioral or serious health/medical problems in the new owner's care, the adopter may return the dog or cat to us but will not hold SACARC responsible for such sudden changes or expenses. Refund terms of adoption apply.
- 9. Return Check Charge:** There will be a \$25.00 charge on all returned checks submitted by the adopter. If the check is not covered, the dog or cat will be relinquished to SACARC.
- 10. Right of Refusal:** To determine what is best for our rescues, SACARC reserves the right to refuse any application.

SACARC does its very best to place only healthy animals for adoption but animals with unknown backgrounds can become sick. If this occurs, you have the option of returning your pet to SACARC, or obtaining treatment from your veterinarian at your expense. If you choose to return your pet after two weeks, NO REFUND will be given.

SACARC agrees to provide the first set of shots and de-worming for puppies and kittens, as well as the REQUIRED spay or neuter surgery at the vet of our choice once the puppy or kitten reaches the appropriate age between 12-16 weeks. For adult dogs and cats SACARC agrees to provide one full set of traditional annual vaccines and de-worming as well as the REQUIRED spay or neuter surgery. The animal will accompany the adopter home and the adopter is responsible for providing all additional veterinary care.

Adoption donation:

Mixed breed dogs over 6 months of age \$85

Mixed breed puppies under 6 months of age \$100

Purebred dogs or puppies based per breed, but minimum of \$200

Cats over 6 months of age \$60

Kittens under 6 months of age \$75

Dogs/cats older than four months are spayed or neutered before leaving the care of SACARC. It is required that all dogs/cats adopted under four months return to SACARC vet of choice for spay/neuter surgery. This is non-negotiable.
